Dear Robert A. Adams:

This letter is to advise you that the contract for the above referenced project has been awarded to your firm at your bid price of \$20,570,001.00.

As a part of entering this contract, the Design-Builder agrees to take all necessary and responsible steps in accordance with 49 CFR Part 26 to ensure that Disadvantaged Business Enterprises have an opportunity to participate in the performance of this contract. The award of this contract was made with the understanding that the DBE Performance Plan submitted with the Design-Builders Proposal will be implemented during the design and construction of the project.

Following execution of the Contract and during both the design and construction portions of the project, the Design-Builder shall submit documentation, in the form of progress reports described in the RFP Section entitled – REPORTING, to show that the Design-Builder is meeting the contract goal for the project, or if the goal is not being met, the Design-Builder must submit satisfactory evidence that I has made good faith efforts, in accordance with that Section of the RFP, to meet the goal. Evidence of good faith efforts, as described in 49 CFR Part 26 Section 26.53, will be monitored by WSDOT throughout the duration of the Contract.

Before execution of a subcontract, the Design-Builder, subcontractor, or lower-tier subcontractor shall submit the following items:

- 1) Information for all utilized DBE's (Using the DBE Utilization Certification form, DOT 21 Form 272-056EF):
 - Correct business name, federal employer identification number (if available), and mailing address
 - List of all items and types of work assigned to each utilized DBE firm, including prices and/or amounts paid

- Description of partial items and types of work (if any) to be sublet to each successful DBE firm specifying the distinct elements of work under each item to be performed by the DBE and including the dollar value of the DBE portion.
- 2) As it occurs, the Design-Builder, subcontractor, or lower-tier subcontractor shall submit the names of firms who submit a bid or quote in an attempt to participate in this project whether they were successful or not. Include the correct business name, federal employer identification number (optional) and a mailing address.
