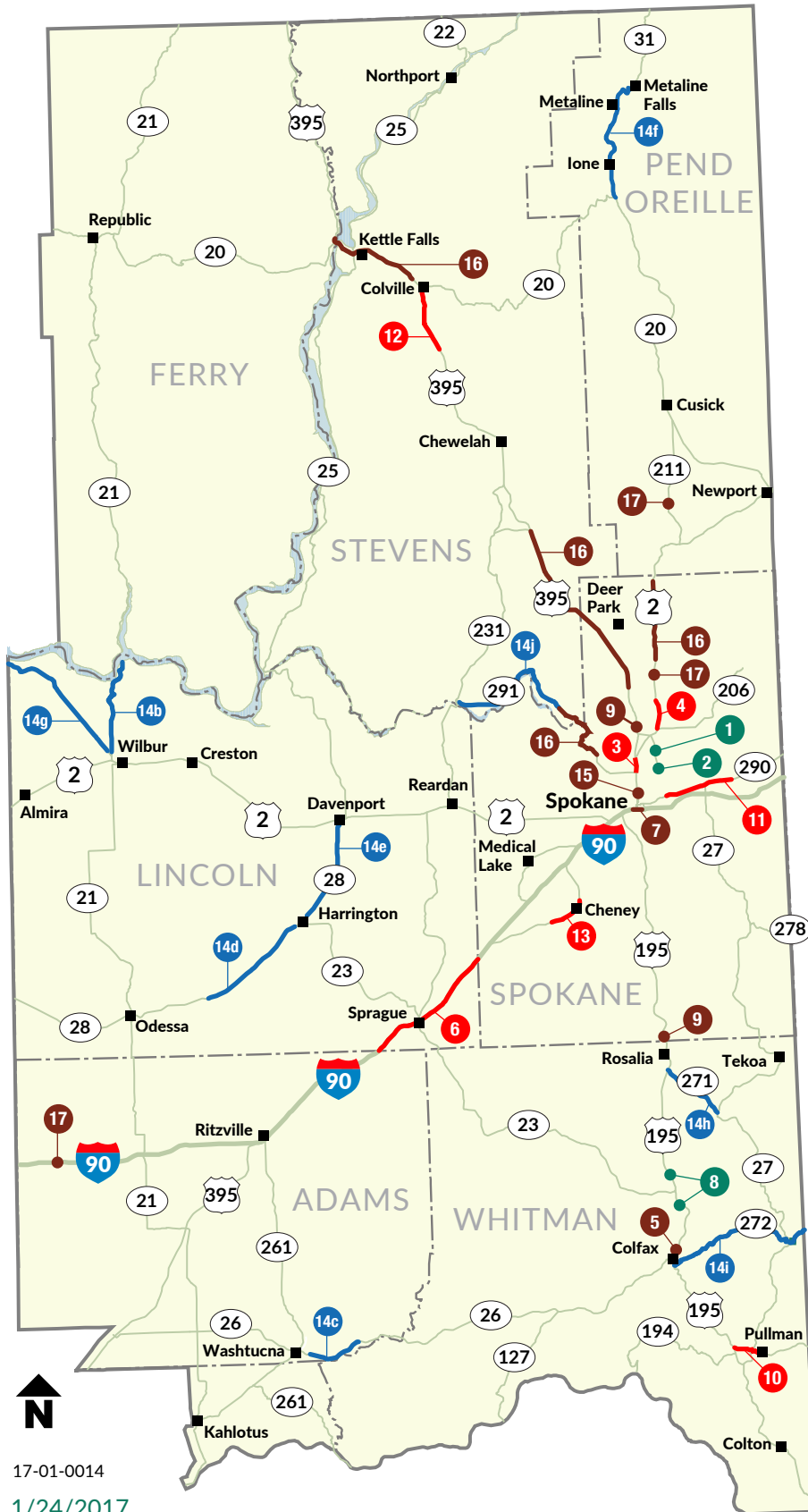


# 2017 Eastern Region Construction
