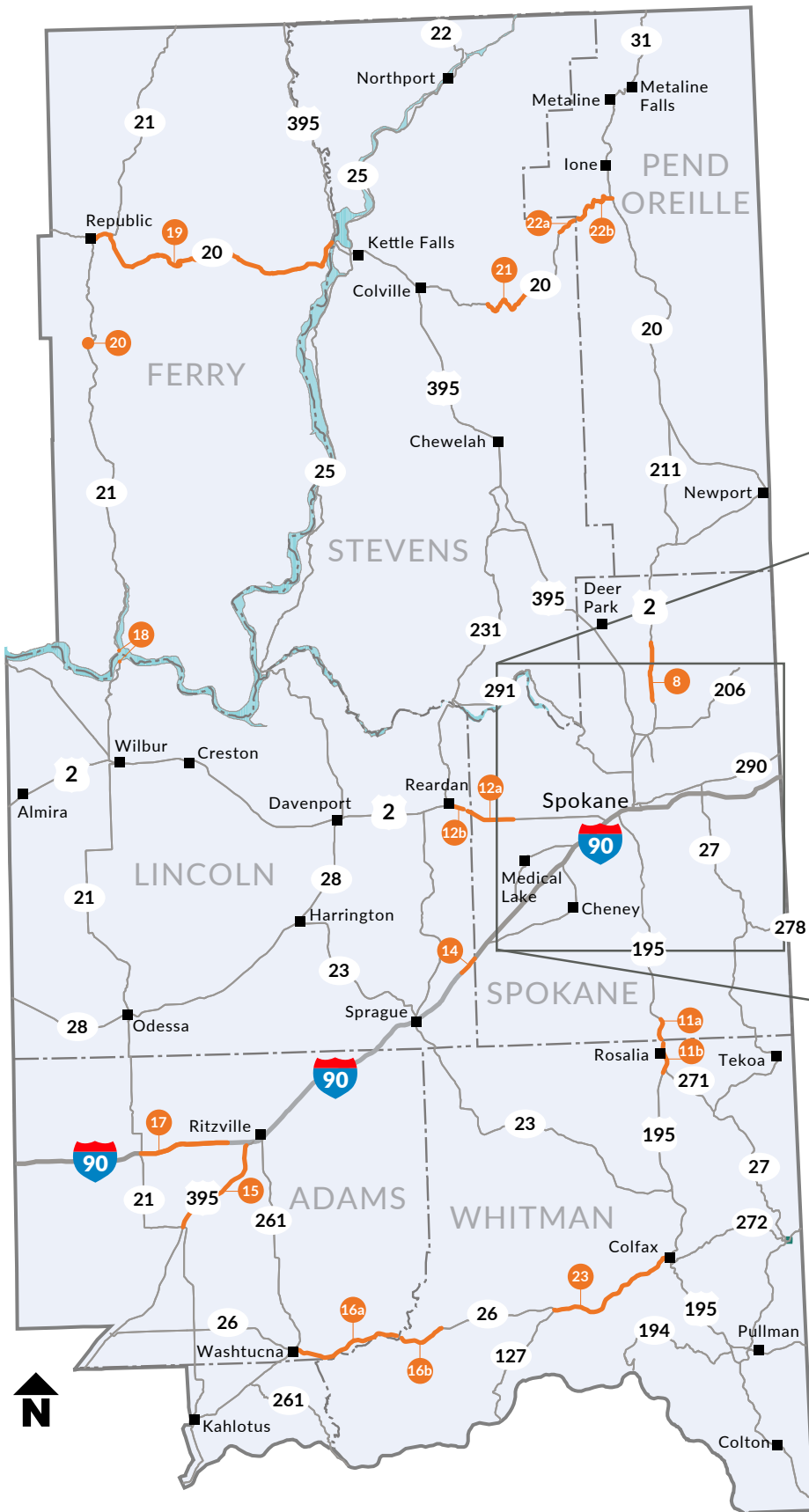
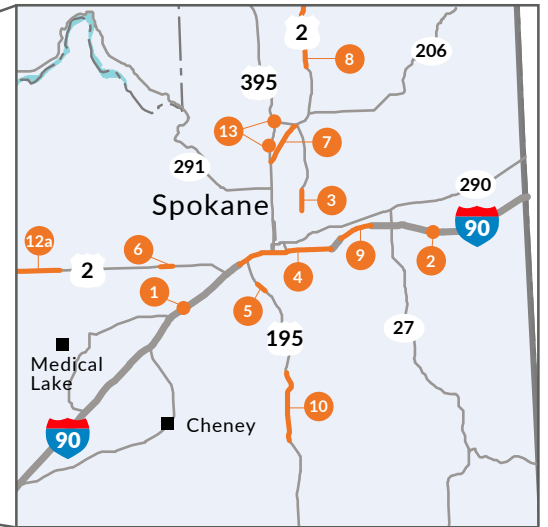


2019 Eastern Region Construction
