## DESCRIPTION:

Unless noted otherwise herein, this Change Order compensates the Contractor for any and all additional costs associated with replacing and extending the original design of an asphalt sidewalk with a concrete sidewalk on the west side of 1st Avenue South from Royal Brougham St. to Dearborn St. It includes additional chain link fence and tree pits with landscaping, in accordance with Exhibit 1 and revised plan sheets RS001 (Sheet 21), RS002 (Sheet 22), RS008 (Sheet 28), PQ1 (Sheet 295), PQ2 (Sheet 296), PV003 (Sheet 303), PV005 (Sheet 305), PV006 (Sheet 306), and PV007 (Sheet 307) as reflected in pages 4 through 13 of 13 of this change order.

## CONSTRUCTION REQUIREMENTS:

Not applicable. There is no change to Contract Construction Requirements because of this change.

## MATERIAL REQUIREMENTS:
