New Washington State Aircraft Dealer's License Instruction

The Aircraft Dealer's License fee is \$75 plus \$10 for each additional plate, please make checks payable to Washington State Department of Transportation (WSDOT) Aviation and send to:

Instructions:

Step 1. Fill in and sign these documents

- a. Aircraft Dealer's License Application (2 originals).
 - i. A separate application and license are required for each branch or sub-agency as though each constituted a separate dealer.
- b. The Aircraft Dealer's License Applications must be notarized.
 - i. Aircraft Dealer's License Bond (1 original)
- c. Aircraft Dealer's Inventory of Aircraft for Sale (1 original)
- Step 2. Submit a surety bond in the amount of \$25,000 running to the state of Washington and executed by your Surety Company authorized to do business in this state with the bond form signed and notarized by the Surety Company.a. This must include a power of attorney from your insurance company.

Aircraft Dealer's Licenses are valid January thru December each year. Renewal requests need to be received or postmarked by the 31st of January each year. (RCW 14.20).

WHEREAS, the Principal has or is about to obtain a license to engage in or continue in the business of aircraft dealer, in accordance with the provisions of chapter 14.20 RCW, RCW 47.68.250 and RCW 82.48.100, and is required pursuant to the provision of said law to furnish this bond in the amount of TWENTY FIVE THOUSAND DOLLARS (\$25,000).

NOW, THEREFORE, THE CONDITION OF THE ABOVE OBLIGATION IS SUCH that, Principal shall at all times faithfully perform as an aircraft dealer, all obligations required by chapter 14.20 RCW, RCW 47.68.250 and RCW 82.48.100; otherwise, Principal shall indemnify and save harmless the State of Washington from all costs and damages by reason of Principal's default or failure to comply with such legal requirements. If Principal so performs, this obligation shall be null and void; otherwise it shall remain in full force and effect.

THIS OBLIGATION is applicable to the license period commencing

and shall continue in full force and effect until terminated by thirty (30) days written notice of cancellation delivered to Aviation Division Director of the State of Washington in writing by the Surety.
