Note: \* Pavement and bridge asset conditions are given as percentage of WSDOT owned highway lane miles in fair or better condition (pavement) and percentage of WSDOT owned bridges in fair or better condition by bridge deck area. Pavement data lags one year behind indication (i.e., 2021 column corresponds to 2020 data). Pavement is part of an integrated approach using Washington State Pavement Management System condition rating, which takes into account all maintenance and preservation work completed and/or needed.
