SR 900/Martin Luther King Jr. Way South Corridor Study


The Washington State Department of Transportation seeks community input for a corridor study on State Route 900/Martin Luther King Jr. Way South in Skyway.

Input from residents, business owners, and road users will help shape the vision of the corridor. This study will set the stage to pursue future funding for the design and construction of highway improvements.

Study background

SR 900 between 57th Avenue South and the Renton city limits is a heavily-traveled commuter corridor with an average of 32,000 vehicles each day. This section of highway lacks sidewalks to connect pedestrians between residences and community hubs.

This study will document the community vision for the corridor and strategies to improve operations, safety, and accessibility for all users.

Study schedule

SUMMER - FALL 2020

- Engage with key stakeholders and nearby communities.
- Gather corridor user feedback through an online survey.
- Collect and analyze survey data.

FALL 2020 - WINTER 2021

- Develop practical concepts based on community input.
- Share concepts with the community and gather additional feedback.

SUMMER 2021

- Summarize findings in a final report.
