Midkood Tigsaar:

- Lacagta buuxda (waa qasab haddii tartanku yahay \$1,000 ama kayar)
- 10% cadadka lacagta tartanka ama \$5,000, hadba kii yar, marka cadadka tartanku ka badan yahay \$1,000, taasoo lagu bixinaayo si buuxda 60 maalmood gudahood laga bilaabo taariikhda furitaanka tartanka iibka
- libka Qandaraaska 10% cadadka lacagta tartanka ama \$5,000, hadba kii yar, marka cadadka tartanku ka badan yahay \$2,500. Isticmaalka Dhismaha: Maamulka maxaliga ah ee maamulaaya dhismaha la carbuunaayo waa in lala xiriiraa si loo helo shuruudaha gaarka ah ee quseeya isticmaalka la ogol yahay. Washington State Department of Transportation (WSDOT, Waaxda Gaadiidka ee Gobalka Washington) ayaan bixinayn wax damaanad ah, mid qoraal ah ama is-afgarasho ah oo ku aadan haboonaanta isticmaal kasta.

Saxiixa: Tartamaha hoos ku saxiixan wuxuu halkaan ugu gudbinayaa Washington State Department of Transportation, tartanka iibsiga guriga kor lagu sheegay. Tartamuhu wuxuu qirayaa, fahmayaa uuna aqbalayaa shuruudaha iyo xeerarka ku jira Notice of Auction (Ogeysiiska Iibinta), General Sale Terms (Shuruudaha Guud ee libka) iyo Parcel Information (Xogta Dhulka). Tartamaha saxiixiisu hoos ku yaalo wuxuu cadeynayaa in midkoodna aniga ama xaaskayga/saygayga uusan ahayn shaqaalaha Washington State Department of Transportation, ama Tartamaha (ama xaaskiisa/saygiisa) saxiixiisu hoos ku yaalo uu yahay shaqaalaha Washington State Department of Transportation uuna haysto ogolaanshaha Xoghayaha Gaadiidka si uu u gudbiyo tartankaan.
