

# Scholarship Application for Highway Construction and Maritime Trades

## About Our Program:

Washington State Department of Transportation's On-the-Job Training Support Services Program (OJT/SS) and Pre-Apprenticeship Support Services Program (PASS) provide pre-apprenticeship training, preparatory, and apprenticeship scholarship opportunities to support the participation of women, minorities, and other disadvantaged individuals in the highway construction and maritime workforce.

## To Qualify:

- 1. Fully complete this application. If any fields are left blank, the application will not be accepted.
- 2. Be a Washington State resident.
- 3. Be a woman, minority, or other disadvantaged individual.
- 4. Provide proof of enrollment of your selected highway construction or maritime trade school.
- 5. Submit your application along with your proof of enrollment to WSDOT by email at OJTSSinfo@wsdot.wa.gov. If you'd prefer to complete this application by hand and mail it in, please send an email to the above listed email address, letting us know of your intent to mail. Then, mail the application and documents to:

## What to Expect:

- 1. Once we receive and review your application, we will respond, letting you know we are in the process of reviewing your information.
- 2. After a decision has been made, we will send a follow up email, informing you of the award or denial.
- 3. Please follow up with the trade school and let them know if you were awarded a scholarship.
- 4. We will then need to receive an invoice from the trade school and will issue payment as soon as possible. Payments are issued in about 30 days.

Due to the popularity of this program and the limited nature of program funding, we will award priority to first-time applicants. We request that all who have recently received scholarship awards limit their second or third requests to quarterly or 90-days between requests.
